2. Verify that the project was approved by an appropriate institutional review board if necessary for the project.
3. Authors will provide disclosure related to funding of the project or potential conflict of interest related to the work presented.

Each first author (presenting author) will receive an email acknowledging receipt of the abstract submission. The first author (presenting author) will receive a letter of notification from the Program Committee regarding its decision by March 30, 2023.
